

## HMDCB RELEASES 2020 INITIAL CERTIFICATION EXAM RESULTS

*Chicago, IL – November 2020* — The Hospice Medical Director Certification Board<sup>®</sup> (HMDCB<sup>®</sup>) has recently completed its seventh examination of hospice medical directors and hospice physicians. The 2020 examination certified 139 hospice physicians from 37 states and had a passing rate of 78.9%.

The 2020 examination covered five main topic areas: patient and family care, medical knowledge, medical leadership and communication, professionalism, and systems-based practice.

Since 2014, HMDCB has proudly awarded the Hospice Medical Director Certified<sup>®</sup> (HMDC<sup>®</sup>) credential to 1,252 hospice physicians who have chosen to demonstrate their knowledge and skills in hospice medicine. More than 1,110 from across the country currently hold the credential.

According to HMDCB's president, Tommie Farrell, MD FAAHPM HMDC, "HMDCB's Board of Directors congratulates the many hospice physicians who have achieved the HMDC credential in 2020. It has been an incredibly challenging year for physicians across the country, and for these leaders to choose to become certified shows the value they see in showcasing their knowledge and skillset in providing effective and quality care for patients and families. We're pleased to welcome them to the list of more than 1,100 others who are currently certified."

The new content blueprint covers five main topics areas: patient and family care, medical knowledge, medical leadership and communication, professionalism, and regulatory compliance and quality improvement.
